## Driveway replacement/repair

Sadly, this didn't happen this year. Why? A combination of factors contributed: early wet weather made the work impossible to start. The vendor who was awarded the contract had a number of major projects that took precedence over work at WWPC. The contract specified completion by August 31, and when that date passed without the work being scheduled, the board cancelled the contract. New bids will be solicited in early spring, and the project will go forward next year.
